Vendor booths MUST remain open during all Festival Hours- NO EXCEPTIONS

NO shared booths. ONE Vendor per booth.

**All vehicles must be moved to general parking area no later than 5 PM on Friday.**

The following items and exhibits are PROHIBITED: fortune tellers, tattoo artists, body piercing, sexually suggestive items or any type of gambling or gambling devices which require licensing by the Kentucky Gaming Commissions, casino games, pull tabs, etc. Free "register to win" is acceptable.  
**GUNS OR TOY GUNS OF ANY KIND ARE STRICTLY PROHIBITED.**

Each Vendor is responsible for collecting and paying Kentucky Sales Tax.

24-hour security will be provided beginning Friday, June 19, 2026 at 5:00 PM and ending Saturday, June 20, 2026 at 11:00 PM. The City of Lyndon and/or Event Logic makes no guarantee and assumes no responsibility for loss, breakage, etc.. Items should be removed at closing or packed away and sufficiently covered.

Vendor/Exhibitor agrees to hold Lyndon's Summer Festival, the City of Lyndon, Event Logic or agents and employees thereof harmless from any liability, loss, or damage.

Each space provided is 10' x 10' and is located in a grassy area. The space is the only thing provided. You are responsible for bringing your own tent/canopies, tables, chairs, personal generator (no electric provided), etc..

**Cancellation Policy- If the cancellation of a Vendor Booth is desired, Event Logic must receive ia written request before May 22, 2026 and the vendor will be refunded 50%. No refunds will be provided after May 27, 2026.**
